## Waverley District Netball Association COVID-19 SAFETY PLAN

The purpose of this COVIDSafe plans is to:

- Provide our plan for the implementation and management of netball activities at WDNA
- Have arrangements set out to prevent the transmission of COVID-19 amongst our community. (Including volunteers, members, participants, coaches, officials, administrators, visitors, family members.)
- Provide a framework to govern the general operations of netball activities at WDNA.
- Tell the behaviours expected of all members, participants, officials, and visitors.
- Inform how we will be monitoring attendance and the report of the health of attendees at the venue.

WDNA accepts as key principles:

- The health and safety of our community attending the venue is the number one priority.
- Clear communication is required for our community on our return to netball plans.
- The importance of upgrading hygiene protocols.
- Measures are put in place to mitigate the risk of transmission of COVID-19.
- Netball activities cannot resume until operations are finalised and approved.
- At every stage, we must consider and apply all restrictions and regulations.
- We need to be prepared for any localised outbreak at our venue.

WDNA retains the responsibility for the effective management and implementation of the return to netball activities and operations outlined in this Plan.

WDNA is responsible for:

- Approving the Plan and overseeing the implementation of the arrangements in the Plan.
- Ensuring the plan reflects up to date information from the Victorian Government and public health officials.
- Revising the Plan as required.
- Complying with the *Coronavirus (COVID-19) reopening roadmap: metropolitan Melbourne*.

WDNA Expects our community to:

- Comply with ALL health directions of the Victorian Government and public health authorities.
- Comply with physical distancing and the wearing of face coverings.
- Understand and act in accordance with this Plan as amended from time to time.
- Act with honesty and integrity on the state of their personal health and any potential COVID-19 symptoms.
- Not attend the venue if displaying COVID-19 symptoms.
- Record their attendance at the venue via QR codes and/or team sheets.

Communications	<p>WDNA will distribute all relevant information to the key contact people for distribution to their members in relation to:</p> <ul style="list-style-type: none"> <li>• Entry and Exit requirements</li> <li>• Our endorsement of the downloading of the Federal Government's COVIDSafe App and encourage the use of this App</li> <li>• Reinforce protocol towards hand washing and general hygiene etiquette</li> <li>• Requirement to advise WDNA of any illness of symptoms synonymous with COVID-19</li> <li>• Our requirements of our community attending our venue</li> </ul>
Cleaning & hygiene	<ul style="list-style-type: none"> <li>• Regular full clean prior to each competition or activity day</li> <li>• Scheduled (2 hourly) clean and sanitised protocols for all indoor areas</li> <li>• Regularly fill soap dispensers in bathrooms</li> <li>• Cleaning equipment to be available in all internal areas</li> <li>• Hand sanitising stations will be provided at entry and exit points</li> <li>• Posters detailing personal hygiene guidance will be displayed</li> </ul>
Communal facilities	<ul style="list-style-type: none"> <li>• Display signage to advise maximum number of people allowed in each space</li> <li>• Limited access to pavilion</li> <li>• QR codes at all entry points to venue and communal areas</li> <li>• Regular clean &amp; sanitise (twice per session) of pavilion &amp; high touch points</li> <li>• Limit access to bathrooms where possible</li> <li>• Recommend shelter seating not to be used</li> <li>• Provide one sanitised rubbish bin for each court</li> </ul>
Communal equipment	<ul style="list-style-type: none"> <li>• Post protectors – to be sanitised between each game</li> <li>• Team bibs are not to be shared with other teams and to be washed after each use</li> <li>• Team balls are not to be shared and are to be sanitised before each use</li> <li>• Team equipment is not to be shared with other teams and is to be sanitised before each use</li> </ul> <p>WDNA is unable to provide balls, bibs or other equipment to teams attending the venue.</p>
Physical distancing	Required by our community as directed by the Victorian Government and health officials
Face coverings	Required by our community as directed by the Victorian Government and health officials
Car park, entry and exit points	<ul style="list-style-type: none"> <li>• Identify and clearly mark pick-up and drop off-points</li> <li>• Clear signage for entry and exit points</li> <li>• Distribute map to community of car parking areas, entry and exit points</li> </ul>
Control access	<ul style="list-style-type: none"> <li>• Courts booking only available to member clubs and known VNL clubs, schools, and Netball Victoria</li> <li>• Maximum number of attendees for each team = 12 (children under 12 months old not included).</li> <li>• Coach, team manager/scorer and support people included in the 12</li> <li>• No spectators</li> </ul>

Attendance & attendance records	<ul style="list-style-type: none"> <li>• If you are unwell or display any symptoms of COVID-19, do not attend the venue</li> <li>• All attendees must register               <ul style="list-style-type: none"> <li>- Outdoor areas                   <ul style="list-style-type: none"> <li>Players – on scoresheet</li> <li>All others including children via displayed QR codes</li> </ul> </li> <li>- Indoor areas                   <ul style="list-style-type: none"> <li>Umpires – through attendance registration</li> <li>All others via displayed QR codes. Separate codes for pavilion, first aide, bathrooms.</li> </ul> </li> </ul> </li> </ul>
Attendance – management of unwell participants	<p>Our first aid attendant will assist in the immediate management and treatment of the systematic person and arrange cleaning and sanitising the indoor facilities used by this person.</p> <p>WDNA will follow the health guidelines on reporting.</p>
Attendee – suspected case of COVID-19	<p>If you display symptoms of COVID19, please ensure you have a COVID-19 test as soon as possible.</p> <p>If you have attended a game at the Ashwood courts and afterwards, are advised to self-isolate or diagnosed with COVID-19, please notify us 'in confidence' at <a href="mailto:secretary@wdna.com.au">secretary@wdna.com.au</a>. All information will be kept confidential however, this allows us to gather information that we may be required to provide to the DHHS.</p>
Attendee – confirmed case of COVID-19	<p>DHHS will notify us of a confirmed case of coronavirus (COVID-19) and will advise if we need to stop netball activities or can continue operating.</p> <p>We will be assigned a case manager from their dedicated and specialised team to ensure we are supported throughout the process.</p>
